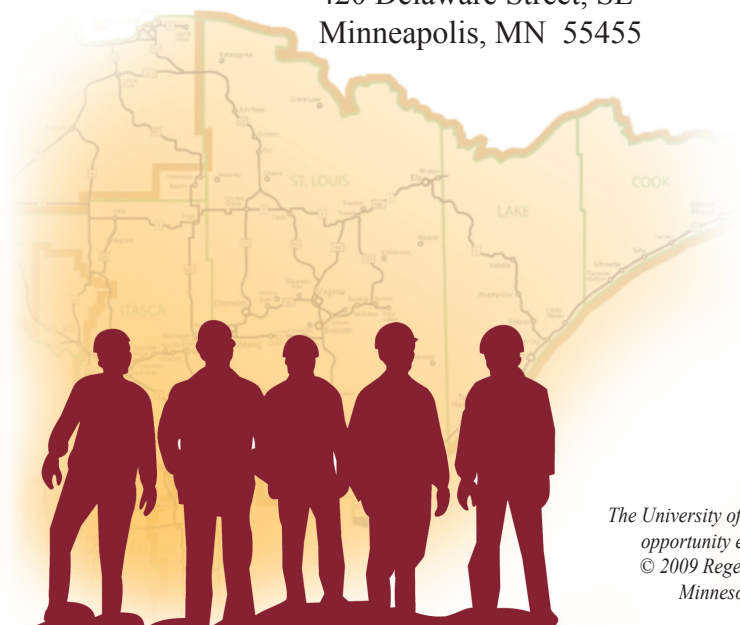

The University of Minnesota study will address worker health concerns

The University of Minnesota has been asked by the State of Minnesota to conduct a very important research study on whether exposure to dust from taconite mining and processing is harmful to taconite workers.

The research study will address health concerns about the impact of breathing dust from taconite operations and the increased number of mesothelioma cases among taconite workers.

As one approach to address these concerns, the University of Minnesota is asking 1200 current and former workers and up to 800 spouses to take part in a research study to evaluate lung health.

You are being asked to participate because your name was randomly selected, in a scientific manner, from a list of current and former workers, or you are a spouse of one of these workers.

You are asked to participate in the Respiratory Health Survey of Taconite Workers and Spouses.

Participation is free and includes the following:

- a health questionnaire
- a chest X-ray
- a physical examination
- a blood sample
- two types of lung function tests

These tests will be performed at the study clinic located at the Virginia Regional Medical Center-Medical Arts Building.

Your participation is important to accomplishing the goals of the study.

You can contribute and help to answer longstanding questions about whether dust from taconite operations affects the lung health of taconite workers and their families.

The University of Minnesota study will provide you with your health information

The direct benefit from participating is that **you will receive a summary of your test results.** You may choose to share your results with your personal doctor. The study team will not share your participation results with anyone else.

This study is designed only to look at lung problems that may be associated with exposures to dust from taconite operations—it is not a general health assessment. It is possible that a previously unknown condition will be detected and reported to you. This may lead to additional costs to you for follow up medical care that is not covered by this study.
